INTRODUCTION

The history of the intercontinental INSP!R network officially begins in November 2019, when a launch event brought together members from the four continents who agreed to unify, at global level, synergies gathering already partners organizations of WSM, ACV-CSC (Confederation of Christian Trade Unions of Belgium) and the Christian Mutuality of Belgium developed at national and continental levels. In reality, though, this story goes back much further: the idea of working in synergy, in a network, of bringing together a wide variety of actors around a common goal—fighting inequality—has always been the DNA of the network’s members. Being connected in a network implies giving ourselves the means to share our experiences and learn from each other, give more visibility to our demands and defend together the ideal of universal social protection. The starting point for the network’s work is the Decent Work Agenda of the international Labour Organization, with the aim of transforming societies while ensuring that no one is left behind. The INSP!R network’s stakeholders are convinced that the best way to lift people out of exclusion and insecurity consists in building or consolidating a genuine system based on solidarity,

which supports these women and men throughout the life course and helps them cope with hardships. This system—social protection—is based on a certain number of human rights, recognised as universal since 1948, and must also be developed and safeguarded. It has proven its worth and can be implemented anywhere, provided that it is supported and involves the political and economic actors and civil society. Social protection should not be seen as a burden, but rather as an investment for more sustainability, inclusivity and solidarity in society.

Mission

The objectives of INSP!R are to contribute to **universal social protection** (USP) and to advocate for the **leading role of civil society** in the implementation of national, comprehensive and widely supported social protection policies.

Vision

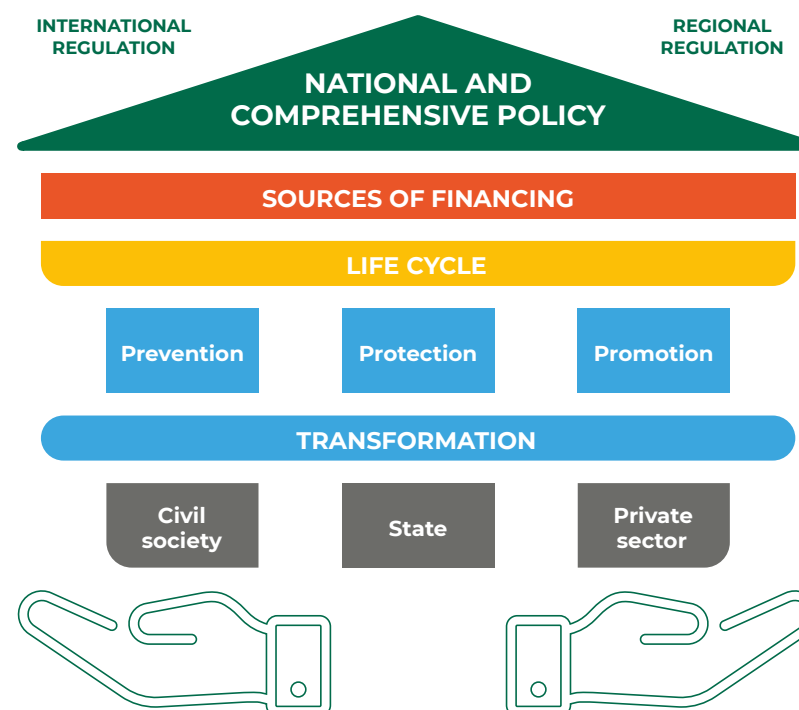
Key principles for successful social protection policies:

- 1) a **rights-based** approach (anchored in national, regional and/or international regulations);
- 2) a **combination of several measures** (prevention, protection, promotion) to provide benefits (in cash and/or in kind) to individuals;
- 3) effective **multi-stakeholder** participation (state, civil society, private sector) to continuously transform the existing policy;
- 4) the need for multiple sources to ensure **sustainable funding** (national and international); and
- 5) a **life-cycle** approach (from birth to death).

Valeurs

The INSP!R steering committee at intercontinental level is designed as a place where the network can exchange and decide on the actions it wishes to undertake together at the international level. Based on the **principle of subsidiarity**, actions taken at the international level should be motivated and aimed at strengthening the actions of the respective networks at national and continental level.

For the sake of good governance, it is important that the steering committee and the coordinating organisation respect a set of common core values, which underpin the action of the network as a whole, such as: **effective participation and joint decision-making, inclusiveness and equity, autonomy and democratic ownership, as well as transparency and accountability.**

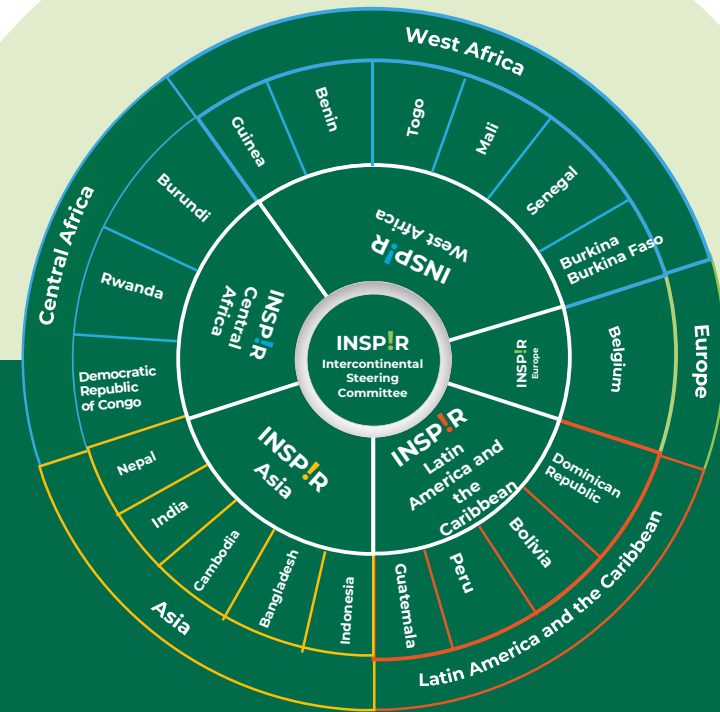

INSP!R, A NETWORK WITH A GLOBAL PRESENCE



Where does the name 'INSP!R' come from?

INSP!R stands for International Network for Social Protection Rights, which underlines the network's global dimension. This name has the advantage of making sense in many languages and refers to inspiration, breath and creativity. The right to social protection remains the cornerstone of the network's struggles, though it encompasses many other rights: the right to health, to a decent pension, to unemployment benefits, to health insurance, to family allowances, etc. This explains the use of 'rights', in plural.

HISTORY

1974

The Initial Foundations

The NGO World Solidarity was created in order to oversee the development cooperation activities of the Belgian Christian Labour Movement and promote **decent work and social protection** to fight against poverty and social exclusion.

2007



Synergy for Change

WSM's Strategic Framework 2008–2013 rechannelled actions towards direct cooperation with partners in Africa, Latin America & the Caribbean and Asia. It also incorporated a continental approach, whereby **networking and synergies** between partner organisations were considered as key components.

2008

Collective Impact

World Solidarity three-year programme 2008–2010 explicitly provided for activities focused on developing a synergy between organisations at **national level**, particularly in Benin, Burkina Faso, DR Congo, Guinea, Guatemala, India and Nepal.

2011



Collaborating for Further Progress

Synergies and networking activities were planned in all the countries involved in the 2011–2013 programme of World Solidarity.

2013

Maximizing the Impact

The 2014–2019 strategic framework **of World Solidarity** called for a stronger positioning of the organisations through political and thematic networks on the right to social protection at **Belgian, European and international** levels.



2014

Towards Continental Unity

The new three-year programme of **World Solidarity** organised the national networks into continental networks in order to enhance thematic monitoring, synergies and exchanges, via a continental steering committee that is self-managed by partner organisations in the continent. The networks had to develop communication on the right to social protection, from the perspective of partner organisations, through **blogs and newsletters**, which were also widely disseminated and consulted.

2019

The Geneva Inaugural Consultation Paves the Way

World Solidarity takes the new name of WSM. The INSP!R network took on a global dimension. The first consultation was organised in Geneva to **set its objectives and working method**. A **visual identity** and the first **working tools** were developed.

2020

Coordinating Actions through an Intercontinental Steering Committee

In the light of significant global challenges, such as the **Sustainable Development Goals–SDGs–**, the **ILO resolutions or the UN initiatives on universal social protection**, the regional networks in Africa, Latin America & the Caribbean and Asia decided to expand their scope and created an **international steering committee** in charge of coordinating actions at intercontinental level.

2022

Uniting Continents for Social Protection: INSP!R's Official Launch

On 3 February 2022, an online webinar brought together more than 300 participants from around the world for the celebration of **INSP!R's official kick-off**. People from various backgrounds attended the event to discuss the network's shared vision and objectives, namely **the fight for universal social protection** and **the recognition of civil society's pivotal role in this mission**.



INSP!R : from the local experience to the intercontinental approach

All member organisations of the network share the same conviction, forged from their field experience with their members and target populations: the importance of defending the right to universal social protection. Diversity within the network is its strength. It involves trade unions, mutual health organisations, NGOs, women's organisations, youth or elderly organisations, social and solidarity economy initiatives, etc. This multi-actor approach gives the network all its legitimacy. However, to ensure that these organisations and the people they defend stand

up for universal social protection, their scope of influence must absolutely be expanded: linking up organisations in the same country to ensure a national reach, drawing on the struggles in neighbouring countries to support a continental approach and, finally, connecting the continental multi-actor networks in order to develop joint activities at intercontinental level. Networking is INSP!R's winning strategy in order to make headway on the right to universal social protection! Because alone, we move faster, but together, we go further.



INSP!R NETWORK SUCCESS STORIES



Advocacy

The network focuses on **fostering** structural change by enhancing **collaboration** with other civil society groups and networks while working closely with international institutions. It leverages political advocacy to amplify the voice of civil society and trade unions in promoting universal social protection.

Capacity building and leveraging opportunities

The network seeks to focus on capacity building and leverage the opportunities provided by **international exchanges: field visits, seminars or research. These activities** are organised among its members from different countries and continents on a regular basis and are aligned with the needs and priorities of INSP!R's members.

Fundraising

INSP!R seeks to foster collaboration with other organisations and donors by proposing joint actions and expanding the network. This allows to pool funding from various streams (**ILO, UNICEF, EU, ENABEL**) and other international funders to effectively shape social protection policies at both local and global levels.

Communication

The network now has a **unique visual identity** aimed at improving its visibility and unifying its communication. This includes the consolidation and alignment of communication channels on **a brand new website (www.inspir.global)** that disseminates information on **the right to universal social protection and the network's contributions** at the global level.

INSP!R NETWORK SUCCESS STORIES

INSP!R's members were engaged during Covid!

Solidarity and care for others are part of INSP!R network's DNA. Our members faced the Covid crisis and always stood with the most vulnerable people in society. They proved that, more than ever, solidarity is key to overcome crises. These social movements were at the heart of the fight to help the vulnerable and precarious populations affected by this plight. A special Covid-19 emergency fund was made available to the members of the network, allowing them to carry out comprehensive actions to address urgent health and food needs. A genuine social protection crisis hit the world, from India to the Dominican Republic, through Niger and the Democratic Republic of Congo! INSP!R Europe is on track!

Since early 2021, WSM (the NGO of the Belgian Christian labour movement), ACV-CSC (Confederation of Christian Trade Unions of Belgium) and the Christian Mutuality of Belgium, which are all INSP!R members, have held regular discussions within the framework of the European INSP!R network. The topics focus on the platform economy and the global care chain in the

context of people's right to universal social protection. The European network is genuinely keen in opening up to other European organisations. A first step has been taken in 2023, when contacts were established with the partners of the Christian Mutuality in Poland, Romania and Moldova.



INSP!R Network is launched during an event

On 3 February 2022, 300 people from four continents met remotely to celebrate the official launch of INSP!R network. During the seminar, participants from various backgrounds (international cooperation, social movements, continental political bodies, trade unions, mutual health organisations, etc.) could hear about and discuss the specific achievements of grassroots organisations as well as the vision and objectives shared by the hundreds of members of the network. They are fighting together to make universal social protection for all a reality, while emphasising the pivotal role of civil society in this endeavour.



Speakers shared several strong messages:

'Social protection is not about survival, but about people's development. It not only protects people's lives: it is a prosperous lever for households and the members of society in an economy that provides opportunities and respects dignity', said Rachel Sabates-Wheeler (Institute for Development Studies).

'We are credible because we talk about what we are going through', said Mamadou Diallo (International Trade Union Confederation, ITUC). 'Our demand for more social protection is rooted in the needs, though, above all, in the (human) rights of the populations/beneficiaries. We do not ask for charity, but rather for fundamental human rights. It's time to figure it out, and INSP!R is here to remind everyone of this too.' He concluded by stressing that 'Social Protection is an investment, and it is financially affordable! We need to push our policymakers to leverage resources.'

INSP!R NETWORK SUCCESS STORIES

The International Labour Conference 2022 achieved significant breakthroughs!

The ILO held its major annual meeting in June 2022. The Confederation of Christian Trade Unions of Belgium, a recognized member of the Workers' Group of the ILO, was present on-site. WSM, the Belgian NGO, was also there to support ACV-CSC in its advocacy. All INSP!R's members were able to feed the debates through both actors, drawing on their field experience to contribute to lively discussions.

The International Labour Conference (ILC) has recognised occupational health and safety as the fifth fundamental right and principle at work. The decision implies the first extension of workers' fundamental rights in a quarter of a century. This was an urgent task: every year, over 3 million workers die from work-related causes and tens of millions more suffer injuries and ill health. This victory, backed by an ongoing three-year campaign led by trade unions, experts, practitioners and victims' families, will help to reverse this deadly trend.

Also, a 'general discussion' on **decent work and the social and solidarity economy took place during the ILC** due to the awareness, at the ILO, of the increasing importance of the social and solidarity economy (SSE).

The general discussion led to the adoption of conclusions under the form of a resolution. They provide a robust definition of the SSE, allowing States to clearly identify the nature of these initiatives (to develop national, regional and local legislation in support of this sector). The document also proposed guidelines to ensure that ILO constituents support the SSE through a range of very specific actions, where appropriate. Finally, it came up with recommendations for an enhanced ILO support to the SSE through various initiatives. In October 2022, the ILO adopted a policy brief, which was broken down into an action plan.

ACV-CSC, WSM and INSP!R were strongly involved in the discussion in Geneva. Indeed, INSP!R's members develop SSE experiences on a daily basis, thereby contributing towards achieving universal social protection.

Advocating for a Global Fund for Social Protection

INSP!R drafted a position paper on a 'Global Fund for Social Protection' (GFSP) in the first months of 2021. The document calls for enhanced, better coordinated and long-term predictable support for social protection systems. We emphasised the need to align such a fund with the ILO standards on universal social protection and to consider the effective participation of social partners and civil society in decision-making. We also organised a webinar to share our position on 24 September 2021. At the same time, at the UN General Assembly, the ILO and the UN came up with the plan for a 'Global Accelerator on Jobs and Social Protection for Just Transitions.' In principle, this accelerator could be seen as a response to our demand for a Global Fund for Social Protection. However, we must guarantee that consolidating social protection is not pushed aside by other objectives. Therefore, we continued our lobbying, together with ITUC and the Global Coalition for Social Protection Floors (GCSPF), in 2022 with a view to make sure that our key demands are not overlooked when the accelerator is launched.

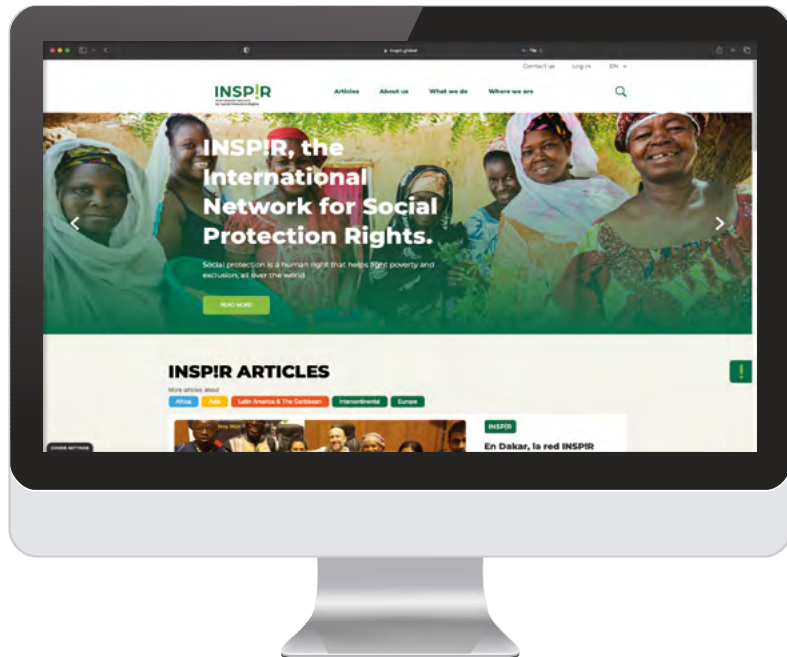


INSP!R PERSPECTIVES FOR 2023–2026

Launch of the INSP!R website

We will launch the new website of the INSP!R network in 2023: www.inspir.global

It will be available in three languages (French, English and Spanish), will introduce all our members and provide explanations about the topics in scope in the network. A dedicated page includes articles that help find out about the members' initiatives and updates on the network's achievements in the area of universal social protection rights.



Ever more workers are protected

In 2022–2026, the INSP!R network seeks to ensure, **through the involvement of all its members**, that more than one million workers (40% of these being women) have access to **decent work**.

Our aim is also that around 4 million people worldwide **benefit from a (public or community) social protection mechanism through social movements that organise mutual health organisations that provide quality healthcare**.

Social protection coverage targets by continent

- **300,000 workers in Central Africa**
(60% women and 25% young people)
- **1 million workers in West Africa**
(53% women and 54% young people)
- **45,000 workers in Latin America**
(40% women and 19% young people)
- **2.5 million workers in Asia**
(56% women and 67% young people)

The INSP!R network aims to submit more than **100 bills and legislative proposals supporting decent work and access to social protection** to international, regional, national and local authorities. More than 200 million vulnerable workers, including women and young people, would benefit from this.

INSP!R PERSPECTIVES FOR 2023–2026

We celebrate 15 years of networking in 2023!

In 2023, the INSP!R members will celebrate the 15th anniversary of the initial launch of the network, which work draws on a common goal: achieving universal social protection for all. Although the network's designation changed to INSP!R in 2022, its activities date back as early as 2008, when national networks were developed based on the members that were committed to upholding this fundamental right. In 2014, these members rallied around continental dynamics in order to influence the political agendas in the regions and share best practices. Finally, the Intercontinental Steering Committee was created in 2019, bringing together representatives from various continents for a better understanding of the global issues that are interconnected with this topic. An event to celebrate this together will be organized in December 2023 - we'll keep you posted!

Towards global 'care' societies!

From 2023 onwards, INSP!R wishes to put greater emphasis on analysing the phenomenon of global care chains in order to ensure progress towards 'global care societies'. This theme will be on the ILC's agenda, at the ILO, in 2024. A 'care' strategy is also being developed at European level. There is a need for quality care structures, in sufficient number and based on solidarity. Care work remains largely unpaid and invisible, and needs to be recognised, redistributed and reduced. Care is a right, not a commodity.

The INSP!R network will be particularly active in this area from 2023 onwards to prepare our contributions for the ILC 2024. The Latin America and Caribbean INSP!R networks will launch a campaign to expand social protection systems and move towards authentic 'care societies'. WSM (Belgian NGO) and ACV-CSC (Belgian Christian Trade Union), in collaboration with the Belgian Christian Mutuality, will also convene an inspiration day in Brussels (Belgium). In addition, INSP!R Central Africa is planning to organise a continental seminar on intergenerational solidarity and the need for long-term care.

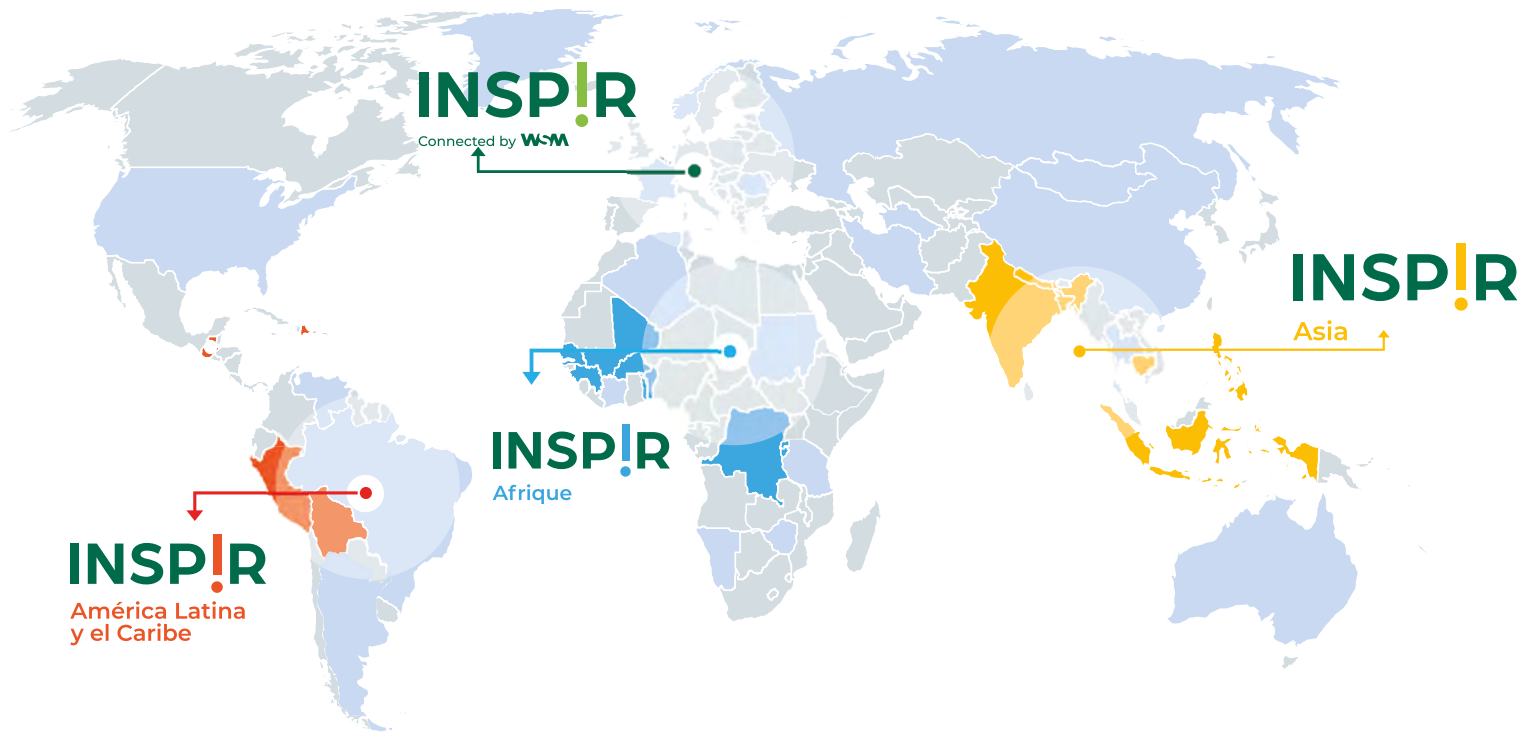
